CSA Program 2017 June 1- September 27, 2017

Demarest Farms, in conjunction with FarmLind Produce, is proud to announce the 2017 CSA Program. A **CSA**, Community Supported Agriculture, program allows the community direct access to farm fresh produce on a weekly basis. The produce will be boxed and delivered to your office or a single designated location in your community for groups of 25 or more. Smaller groups or individuals can pick up their share at the farm. Advance payment allows you to commit to a “share” of farm fresh produce. Throughout an 18 week period, every Wednesday, starting June 1st you will receive a variety of fruits and vegetables.

Convenience, **S**ervice, and **A**dventure await you as you commit to a “share” of nature’s bounty. Full and Half shares are available.

Full Share

(about 3-4 servings)

What’s in the box (sample)*:

- 2 pounds of tomatoes
- 2 pounds of peaches
- 6 ears of corn
- 1 pound of string beans
- 1 pint of blueberries
- 2 zucchini
- 1 eggplant
- 1 jalapeno peppers
- 1 head of lettuce

* Actual produce will vary week to week

Half Share

(about 1-2 servings)

\$350 If Paid by 5/1/17

\$375 If Paid after 5/1/17

What’s in the box (sample)*:

- 2 ears of corn
- 1 head of lettuce
- 2 zucchini
- 1 pound of tomatoes
- 1 pint of blueberries
- 1 pound of peaches

* Actual produce will vary week to week
